Votes taken since last Meeting:

That WFDF Board recommends to WFDF Congress that Israel, Poland and Latvia be transferred from Provisional Members to National Members due to their participation in 2010 events and previous WFDF events. Israel to be charged full annual fees for 2010, and Poland and Latvia to be charged half year fees, since they played their second events in July/August 2010. Approve - 10, Disapprove - 0, Abstain - 0. (26 September 2010)

Proposed Election Policy 6.0 (dated 5 October 2010) and Election Announcement 2010 have been posted to the WFDF Yahoo group. Do you approve of these documents as posted? Approve – 9, Disapprove – 0, Abstain – 0. (17 October 2010)

That the WFDF President send the World Beach Games Questionnaire, as circulated to the Board on 26 June 2010, to SportAccord (possibly with minor edits to update data). Approve 7, disapprove – 0, Abstain – 0. (26 September 2010)

That WFDF enter into the contract with the organizers of WJUC2010 as documented on the WFDF Board Yahoo group. Approve – 8, Disapprove – 1, Abstain – 1. (1 October 2010).

## **Executive Director Report - Kevin Givens**

Invoices/Dues/Sanctioning Fees

-Invoices have been set up for the World DDC Championships and the World Distance Championships, waiting on mailing address for the Distance event to forward invoice. Provisional Memberships

- -Sent a letter to Israel indicating that they are being moved to Full Member and they are responsible for paying their Dues for 2010. Have not received a response to this letter.
  -Sent letters to Latvia and Poland indicating that by participating in more than one WFDF Major Event this year, they need to become Full WFDF Members and pay half dues for
- 2010.
  Survey Monkey Polls (18 voting members and 49 votes in favor pass a proposal.)
  - -2010 Congress Minutes: 22 of 35 members have voted showing 53 in favor, 0 against and 4 abstaining for a total of 60 total votes. Poll opened on September 23 and therefore has been open the required 30 days. Poll will closed after today's meeting.
  - -Proposal 2010.16 Separation of U19 from World Ultimate Events: 25 of 35 members have voted showing 62 votes in favor, 5 against and 1 abstaining for a total of 68 total votes. The poll was set up on September 8<sup>th</sup>. Poll will be closed after today's meeting.

-2010 Budget. This Poll is still open and will remain open until at least November 14<sup>th</sup>. Currently, 13 members have voted showing 32 in favor, 0 against and 3 abstaining. -Event Participation Survey: 352 responses have been recorded. Requests for responses have been sent out via memberlink, via website email for WFDF Members as well as all team contacts from WUCC. We are seeing some clear patterns so far that will help us with future events. The new Events Manager Deirdre Morris-Abrahamsson is currently working on the details of the report and will use them to assist her in the updates of our event documents.

Veitl inquired about two leftover proposals from Congress. Per Potts they are on hold at this time.

### Treasurer's Report – Kate Bergeron

2010 Year to date financials – see attached Financial Report through September 2010.

There are a few items that are improperly coded but are in the process of being corrected.

2011 Budget. Not prepared to discuss at this time.

Potts: What is status of final reports from WUCC, WJUC, WU23. Per Givens we have contacted them but none have submitted.

ACTION ITEMS: (Kevin Givens) Follow up via telephone with all three organizers to request 2010 WJUC, WUCC and WU23 final reports and timeline for receipt.

ACTION ITEM: (Kevin Givens) Send email to a) WUCC organizers with specifics (section 15) from Event Contract with the information that is to be included in their report and b) to WU23 and WJUC organizers with a WFDF template of the types of information to be included in a final report.

## **Old Business**

Auditor – Bergeron is in communication with proposed auditor in Boulder, CO.

Anti-doping. Hammerly provided brief report based on information provided to her by Si Hill. Hill has spoken with one of our contacts at Drug Free Sport Unit in SportAccord however she was unable to provide a definitive answer on whether WFDF will need to do testing in 2011. While it is up to WFDF to decide what their program will look like, WADA has made a recommendation on what IFs should be aiming for including in and out competition testing (including no advance notice testing), TUE system, and an information and education program.

Potts: It is in the best interest of WFDF that we have a logical plan in place that we can present to WADA (even if it does not include all components) so that it appears that we are making best effort we can within our limited abilities.

<u>Action Item:</u> Hammerly/Potts/Hill. Obtain formal recommendation from Si Hill and Anti-doping committee as to what WFDF should plan to do in 2011 in regard to anti-doping testing. Hill to talk to WADA and get clarification as to WADA requirements could be for WFDF in 2011. Hill and Anti-Doping Committee to prepare written recommendations for presentation and discussion at November 14 WFDF Board meeting.

Recommendation that Hill contact other small World Games sports and determine what their plans are in regard to anti-doping in 2011.

Veitl if we are going to drug testing then we should get approval of members. Rauch reminded the group that Congress adopted WADA code in 2003 so technically they have already done so.

## **New Business**

Beach Ultimate Report - Patrick can der Valk.

Interest in World Beach Ultimate Championships (WBUC) is strong. Thus far the following number of nations have indicated interest in sending teams with a team size of 15 athletes or less: Open (20), Women (14), Mixed (22), Masters (9), Mixed Masters (6), Grandmasters (4), Jr Open (5), Junior Women (1), Jr Mixed (2). New Website should be live in the next 2 weeks.

A question has been raised by the Italian Federation as to what relationship should be with IFDF since the event is being hosted in their country. Van der Valk in contact to clarify concerns and whether their involvement will add value to the event.

Beach Juniors – not sure if it's going to only have interest from open 5, mixed 2, 1 women. Will do a last push and make a final decision in January.

Givens: Do teams have to be members of WFDF in order to participate? Van der Valk: This was not a BULA requirement when the issue was announced so he does not think that he can force the issue in 2011. Potts: we really need Beach Ultimate to try and get countries to begin the process to become provisional members. Van der Valk to forward a list of countries that he thinks are planning to participate based on his current records.

Potts: Has a contract been signed with the event organizers? Yes, Van der Valk to forward a copy of its not already in the proposal.

Potts: What's happening with merchandise? Van der valk: Working on a merchandise bid request that will be sent to various Ultimate companies as well as non-Ultimate companies. Potts: what about television/video/broadcast rights? Matt Kass (BULA Japan) has been put in charge of broadcasting rights for the event. Kass has suggested that in order for him to do his work he will need an "official" role within in WFDF so he can create a plan and make commitments. Van der Valk seeking input from WFDF on how this could be accomplished.

**Events manager** – Deirdre Abrahamsson has been selected and is on board, contract is signed. Right now she is focused on developing bid documents for 2012 events. Van der valk: is she

available to help with Beach Ultimate activities. Hammerly: submit ideas for where you might benefit from help to ExComm and we can add/consider as she completes existing projects.

**Full- time executive director.** Job description is out and we are receiving applications. At this juncture Search Committee has recommended that we keep Kevin on staff through the end of first quarter of 2011 to assist in transition.

**Motion:** to retain Kevin Givens on staff through the end of March. Retain him on an as needed basis after that date based on mutual agreement between WFDF, Kevin Givens and new executive director (if one has been identified). **Rauch, Second Potts. Approved – 7, No – 0, abstentions.** 

<u>WFDF Proposal 2010.23</u> Establishment of Semi-Annual Intake Periods for WFDF Membership submitted by Ultimate Canada

**Proposal wording:** The WFDF establish 2 intake periods per year for new membership applications.

Action item – Hammerly/All Board. Hammerly to start WFDF Board discussion thread on this proposal immediately following meeting. All Board members to share thoughts ASAP in preparation of vote on this proposal.

It was suggested that three additional proposals submitted by Ultimate Canada: WFDF 2010.20 Disclosure of process for World Championship seeding, WFDF 2010.21 18 Months notice of World Championships bid allocation process, and WFDF 2010.22 Bid Allocation Notification Requirements be sent to the Ultimate Committee for their review and comment.

<u>WFDF Proposal 2010.24</u> **UP Fiscal Sponsorship and Columbia Partnership** submitted by David Barkan to Kate Bergeron, Robert Rauch and Sandie Hammerly.

**Proposal #1:** We would like to develop and sign a contract to enable WFDF to become the fiscal sponsor for UP. We want to make this arrangement as soon as possible, and would want to it to be mutually understood that it would be temporary until our 501c2 status is granted. It is our understanding this could take approximately 3-4 months. We would propose a standard fiscal sponsorship model, assuming we would tailor it together to our mutual needs.

**Proposal #2:** Ultimate Peace would like to collaborate with WFDF and Colombia Ultimate to create a special event alongside the World games in 2013. Our intent would be to bring cross-cultural teams from around the world to participate in a high profile tournament and celebration of SOTG. The next three years would involve working together to make this happen. We would also use these planning years to both enhance Ultimate in Colombia and continue to grow the sport in the region.

Rauch: Ask that we consider immediately Ultimate Peace proposal #1 that we serve as their fiscal sponsor due the fact that they are about to lose relationship with their current fiscal sponsorship. Hammerly is familiar with managing such relationships as she done similar thing while at the Ultimate Players Association. Recommend that WFDF charge a small administrative fee for providing this service (5% of contributions). Rauch recommends that administrative fees collected be allocated first to direct expenses and then 50/50 to general development programs of WFDF and b) the 2013 joint program in Colombia.

Loreto supports email sent by Rauch and supports this proposal. Need to engage Colombia in the discussions.

**Motion:** to serve as UP fiscal agent. Details to be worked out by ExComm with Ultimate Peace. Rauch, second Hammerly. **Yes – 7, No – 0, abstentions – 0.** 

Loreto supports email sent by Rauch and supports this proposal. Need to engage Colombia in the discussions.

Balance of proposal will be discussed in relation to WFDF overall plan for development including development grants and possible relationship with Peace and Sport.

Meeting adjourned due to time.

WFDF Financial Report through September 2010 Kate Bergeron WFDF Treasurer Prepared October 24, 2010

## **Financial Summary:**

At the end of the third quarter, WFDF has posted sanctioned event fees from WUCC and WJUC (Heilbron) and U-23's in Italy. We still await final reports from the events to close out the full financial report.

Expenses are running on track at about 52% of our budget, while income is running well ahead. WFDF will need to finalize accounting with the WUCC and the other sanctioned events to see if we have any remaining funds that will be incoming.

Our overall cash position is relatively strong at this point in time and we will continue to maintain the larger sum of our funds in our money market account in order to earn some interest, albeit small.

Unclassified deposits have been reduced to one line item that is in the process of being resolved. (Note: these will be reclassified as dues – I have confirmed the funds)

A dues update for 2010 will be attached with the majority of our members in good standing and very few remaining to donate funds. We are working with the Executive Director to close on members that should be transitioning from provisional to full status member and may realize a small amount of additional dues revenue from these members.
