## Allocation Rules

1 All countries get 1 bid for each division where they sent at least 1 team at WUCC 2010 (77 Bids)
2 Countries that finish in the top 10 of the open, women's, mixed and masters divisions at WUGC 2012 get a bid for that division (38 Bids)
3 Regular Members* who don't have a bid from the above 2 allocations get a single bid in the division of their choice (10 Bids)
4 Provisional Members** who sent a team to WUCC 2010 get a single bid in the division of their choice (Belarus, Croatia, Estonia, Luxembourg, Ukraine) ( 5 Bids)
5 Host Nation (Italy) awarded single bid in Masters to allow at least 1 team in each division from host country (1 Bid)
6 For each country sending more than 10 total teams to WUCC 2010, additional bid per division IF number of teams attending in each division is not equal to or
greater than current allocations from above 5 conditions. ( 16 bids)
Womens Masters Single bid for each of 6 countries participating in WUGC 2012 (not included in (2) above due to lack of history) plus 1 bid for Finland and 1 bid for Italy. (8 Bids)
