#### **Auditors' Report**

We have reviewed the financial statements, general ledger, budget, and bank statements for 2007. The financial documentation of WFDF is in good order and revenues and expenses are reasonably in line with the budget approved by Congress.

It is positive that most member associations are in good standing with respect to their membership dues. The income side follows the budget closely. However, we note that in 2006 and 2007 expenses were in most cases significantly under budget. While this is positive on the surface, it is not favourable if it means that planned programs were not performed. WFDF is an organisation to promote disc sports world wide and the primary objective is not to make money. The financial resources are there to support the actions decided by Congress in pursuit of the goals of WFDF.

Looking forward, with a big part of revenues coming from Ultimate world championships sanctioned by WFDF, WFDF's revenues fluctuate significantly depending on whether the WUGC or WUCC are played in a given year. Nonetheless, the expenses for administering the organization should be about the same from year to year. Accordingly, the organization should monitor administrative contractors' expenses to ensure that fixed expenses of the corporation do not become excessive given the fluctuations in revenues.

We recommend that the financial report of WFDF for 2007 be accepted by the members.

### World Flying Disc Federation Notes to Financial Statements

### Note 1: Basis of Presentation

This financial report has been prepared on the cash basis of accounting. The cash basis recognizes revenues when collected rather than when earned and expenses when paid rather than incurred. At year end, checks deposited but not cleared, or written but not cleared, are recognized in the year in which they were deposited or written, and are netted in the balance sheet from the actual year end cash balances. Under the cash basis, therefore, there are no accounts receivables, inventories, or accounts payable accounts on the balance sheet, long-term assets are not capitalized, and hence no depreciation or amortization is recorded, and liabilities are not recorded except as a memo item.

The US dollar (US\$ or \$) is the functional currency of WFDF. Amounts are translated from other currencies as of the date paid in cash.

#### Note 2: Corporate Organization

World Flying Disc Federation (WFDF) is legally incorporated in the state of Colorado, USA. As WFDF's purpose includes "fostering international amateur sports competition," it has officially been recognized as a tax-exempt organization under IRC Section 501(c)(3) of the US tax code since 1994. WFDF is a member of both the General Association of International Sports Federations (GAISF) and International World Games Association (IWGA) since 1995.

WFDF is a federation of international flying disc associations. There are no individual members. As of December 2007, there were 25 Regular Members, 6 Associate Members, 3 Organizational members, and 41 formal and informal Provisional Members and Country Contacts. Of these members, there are associations in 70 countries represented, from Africa, Asia, Australia, Europe, North America, and South America. Member associations representing disc disciplines include: Ultimate Players Association, Professional Disc Golf Association, Guts Players Association, Freestyle Players Association, and Beach Ultimate Lovers Association. Additional member information is included in Notes 3 and 8.

#### Note 3: Changes in Status of Membership

As of December 31, 2007, the following members were in arrears with respect to dues payments and were considered not in good standing: Federação Paulista de Disco, Freestyle Players Association, Philippine Ultimate Association, Singapore Ultimate Players Association, Slovak Association of Frisbee, and South African Flying Disc Association.



### Note 3: Changes in Status of Membership (cont.)

At the 2007 Congress, two new organizations were approved as Regular members: Philippine Ultimate Association, Singapore Ultimate Players Association

During 2007, two previous Regular Members – Swiss Discgolf Association and British Disc Golf Association – chose to voluntarily terminate their membership in WFDF. The reason given for such termination was that their interests were represented by the Professional Disc Golf Association.

#### **Note 4: Payments to Administrative Contractors**

WFDF has engagements with several independent contractors to perform administrative work for the organization. Aggregate payments in 2005 and 2006 were as follows:

In December 2006 Anne-Marie Carey of Vancouver, Canada, became an independent contractor for WFDF with a contract that is to average approximately 20 hours per week, for which she receives a consulting fee of US\$1,750 per month. Her position combines the administrative and event work previously handled by Jonathan Potts and Deirdre Abrahamsson. Dan Roddick continues to provide consulting assistance with respect to individual event, record keeping, and other special tasks. Dan is paid on the basis of an hourly stipend of US \$25.00 per hour, with reimbursement on a quarterly basis in arrears.

#### Note 5: Bank Fees

WFDF pays fees to make or receive wire transfers. Wells Fargo typically charges US\$ 32 per outgoing wire transfer and US\$ 10 per incoming wire transfer. In connection with the receipt of membership dues, WFDF absorbs the receipt charge (although Members are responsible for the wire initiation fees on their end). WFDF also established a PayPal account in 2006 through which it can accept dues payments for Members whose dues are less than approximately US\$1,000, for which it pays fees of 2.9% plus 0.30%, plus a 0.50% cross border surcharge.

#### Note 6: Bank Accounts

WFDF maintains its bank accounts with Wells Fargo Bank, the only bank in the United States to hold the highest possible credit rating, "Aaa," from Moody's Investors Service. Wells Fargo & Company is the fifth largest bank in the US with \$549 billion in assets of September 2007. WFDF has both a checking account and a money market account at Wells Fargo. WFDF also maintains a money market account with PayPal. Balances as of December 31 were as follows:
